

When submitting your grievance, ensure to include :

- i. **Application Reference Number (ARN)**
- ii. **Jurisdiction details : Specify whether it's under Centre or State jurisdiction.**
- iii. **Brief description of the issue : Clearly outline the problem you're facing.**
